# #TAG DIALOGUE TO BE LAUNCHED ON 15 AUGUST

JOINTLY ORGANIZED BY EROPA AND
UP CIFAL PHILIPPINES

In reference to the article entitled "Public Administration Talk" (PA Talk) on the December 2018 Issue of the EROPA Bulletin Nos. 3 & 4 (pp. 11-12), PA Talk – which was a working title back then – will be re-branded as #TAG Dialogue and launched this 15 August 2019.

#TAG (read as hashtag) stands for #ThinkingAboutGovernance. will be accompanied by the tagline "Challenging Governance Ideals and Realities". The use of an octotorphe or hash symbol (#) before the acronyms T-A-G points to the symbol's relevance to social media. In such situations, hashtags "provide a way for the public to express their sentiment". This is something many individuals (and even institutions) feel compelled to do - most especially in the case of matters where it concerns the general public. To this effect, it is like an information lifeline. In today's day and age, individuals cling and/or depend on it - to learn more about an event/issue and use it as an outlet.

EROPA and the University of the Philippines - Centre International de Formation des Autorités et Leaders (UP-CIFAL) Philippines are holding #TAG On the Move: Dialogue on the Move on 15 August 2019, 2:00 PM to 4:00 PM at the Case Room of UP NCPAG, Quezon City, Diliman, Philippines.

EROPA and UP-CIFAL Philippines are cognizant of the fact that migration is a defining feature of today's globalized world – as it aff-

ects the multifaceted dimensions of development at all levels. As are still many misconceptions on the said phenomenon, it is in this view that both organizations endeavor promote Sustainable Development Goal (SDG) 10.7, "facilitate orderly, safe, and responsible migration and mobility of people, including through implementation well-managed planned and migration policies", and the Global Compact for Safe, Orderly and Regular Migration (GCM) Objective 17 which includes "eliminat[ing] all forms discrimination and promote evidence-based public discourse shape perceptions migration".

The two topics that will be discussed are (1) "Debunking the Myths of Migration" by Dr. Orlando Mercado, **EROPA** Secretary-General; and (2)"Unpacking the Balikbayan Box" by Mr. Rex Varona, International Labour Organization Philippines, National Project Coordinator. The talks by the two experts will be recorded in front of an audience and will be published on various types of online mediums. Dr. Pan Suk Kim is a Professor of Administration in the Public College of Government and Business at Yonsei University. South Korea. He was the Minister of Personnel Management of the Republic of Korea from July 2017 December 2018 and Secretary to the President for Personnel Policy in the Office of the President from December 2003 to January 2005.

Dr. Kim received two awards at the 2019 Annual Conference of the American Society for Public Administration (ASPA) in Washington, DC.

# Authors of the Article, Unique Identification Based Online Census System for Electronic Governance

### **Article Abstract:**

Census refers to the socioeconomic data collection process aimed at creating a community's citizen database. Meanwhile, egovernance refers to the delivery of state and central government information and services to its, citizens, businesses within the community, and different institutions with the use of Information and Communications Technology (ICT). In this study, a Unique Identification Based E-Census System was proposed (specifically, the Aadhar, Unique Identification Authority of India). Based on the existing census system in India, various modules of the proposed e-census system were designed, implemented, integrated, and verified with a simulated database. The various online modules include online data capturing, integrating with census systems Aadhar database, census data monitoring, and utilizing the online census database various e-governance applications. Relevant user interfaces are also designed for updating birth and records, utilization of e-census data for next censuses in

addition to reducing manual intervention. This study also demonstrated that e-census data can be used for various decisionmaking applications - i.e. opening educational institutions, granting unemployment allowance, etc. This is possible as online census data is linked to various public institutions' service delivery and all required data is available online. The study concludes that online censust system not only has the potential to replace the manual system but can also allow efficient and a more effective egovernance.


