## AWARDS CRITERIA

- 1. Nominees are evaluated on their exceptional contribution to socio-economic development through public service.
- 2. Nominees must have complied with all the rules of the contest.
- 3. Citizens from the EROPA region (India, Indonesia, Japan, Korea, Nepal, Philippines, PR China, Thailand, Vietnam) are eligible for nomination.
- 4. Nominees must not be more than 35 years old. A certified true copy of the nominee's birth certificate or any equivalent should accompany nomination.
- 5. Nominees must be engaged in public service for not more than five years with documented proof subject to verification by the organizers of the EROPA Outstanding Young Practitioner Award.
- 6. This award is given to recognize young public service practitioners who have proven themselves worthy of honor and emulation based on the following criteria:
  - a. Excellence and integrity in their respective fields of endeavor (40%)
  - b. Pioneering spirit and innovativeness as demonstrated in their fields of endeavor (40%)
  - c. Service to community/nation/region (20%)

## RULES ON SUBMISSION OF NOMINATION

- 1. Any person or organization can nominate one or more individuals.
- 2. Nominations should be made on the official nomination form of the EROPA Outstanding Young Practitioner Award. All information therein should be submitted in English.
- 3. Two (2) digital copies of nominee's picture (2' x 2') should accompany the official nomination form.
- 4. A one-page Executive Summary of the nominee summarizing the important facts and accomplishments as presented in the Digital Album shall accompany the official nomination form.
- 5. The Digital Album shall be subject to specifications indicated in the technical requirements.
- 6. All entries are to be submitted online to the email addresses of the representative institution located at the nominee's country of origin with the subject "EROPA OYP 2012 Nomination" on or before 27 August 2012. Said email addresses are listed at the end of this document.
- 7. The Screening Committee, composed of EROPA State Representative Institutions, shall select the winners. Each Representative Institution is responsible for selecting the winner from their country of origin. There will only be one winner per country every contest year. The Screening Committee's decisions are final and are not subject to appeal.

- 2. What are the nominee's exceptional achievements or contributions to socio-economic development through public service?
- 3. Name honors, awards, testimonials which validate the nominee's achievements or contributions.
- 4. How did the nominee's accomplishments result in the improvement of public welfare?
- 5. Why is the nominee a good role model for fellow young practitioners?

#### TECHNICAL REQUIREMENTS FOR THE DIGITAL ALBUM

- 1. The official nomination form (pages 1 and 2), together with the nominee's certified birth certificate or equivalent, one-page executive summary as well as all other documentary, photographic, and supportive evidences shall be part of the Digital Album.
- 2. Each page of the Digital Album should be numbered. The Digital Album shall be limited to 20 pages only.
- 3. All text present in the Digital Album should have a font of Arial, sized 12, double-spaced.
- 4. All pages of the Digital Album should be sized A4.
