EROPA Gets Ready for 48th Executive Council Meeting, Seminar on Governance as Partnership

Preparations are now underway for the 48th Executive Council Meeting to be held November 10 this year in Bangkok, Thailand.

Following the Executive Council Meeting, EROPA will convene in the same country venue a seminar on the theme "Governance as Partnership: State, Civil Society and Market Organizations." The seminar will be held from 11-13 November.

The seminar wil be hosted by the National Institute for Development Administration of Thailand, an institutional member of EROPA.

The 48th Executive Council Meeting is expected to tackle the strategic direction EROPA will take in view of the changes that have occured in the global public administration millieu. It will also discuss administrative matters left pending since the last Council Meeting.

The Executive Council Meeting takes place a year after the scheduled bi-annual General Assembly, then slated to be held November 2001 in Tehran, Iran, was postponed as a result of travel anxieties following the September 11 incident in the United States.

That General Assembly would have been hosted by the Islamic Republic of Iran through its International Cooperation Bureau, Management Planning Organization.

The decision to postpone the general assembly and to hold the Executive Council Meeting in another venue was taken after a referendum held among members of the Executive Council, and after majority of the EROPA members intending to participate in the Assembly indicated that they might not be able to participate.

In the referendum, Council members were asked to decide on

CALL FOR PAPERS

Eastern Regional Organization for Public Administration Seminar November 11-13, 2002 Bangkok, Thailand

Main Theme: Governance as Partnership: State, Civil Society and Market Organizations

Sub-Themes:

A. What Makes for Successful Public Sector Reform?

Papers in this sub-theme will document and analyze countries' experiences in introducing, implementing and sustaining public sector reform initiatives. These reform efforts may involve the participation of the state, civil society and market organizations. Accounts of these experiences may also examine the administrative reform processes for purposes of identifying forces that may promote or impede the success of these reform efforts.

B. Civil Society's Role in Rethinking and Forging Collaboration

This sub-theme will focus on the role of civil society organizations in rethinking and exploring new models

of collaboration between and among state, civil society and market organizations.

C. Decentralization and Local Governance

How has the policy responses to and the clamor for the greater decentralization of power from national to local government units affected partnership among state, civil society and market organizations at lower levels of government?

D. Fiscal Reforms and Good Governance

This sub-theme will examine a range of fiscal reforms in areas of taxation, budgeting and public debt management. It will also discuss mechanisms that engage state, market and civil society organizations in introducing policy and institutional changes aimed at improving the

countries' financial capacity to provide for increasing development needs.

E. Promoting Partnership through Human Resource Development Strategies

This sub-theme will present HRD initiatives, strategies and policies spawned by the intent of countries to introduce changes that are supportive of an openness to, and an appreciation of the value of greater partnership between and among state, civil society and market organizations.

F. New Technologies for Improved Governance

Papers in this sub-theme will address these concerns:

whether to push through with the original schedule and venue.

Majority of the Council members favored holding the Executive Council meeting in another venue and postponing the General Assembly. Also, majority of EROPA members who have earlier signified their intention to participate in the General Assembly expressed concern on travel security at that time, thus deciding to withdraw their participation.

Some members also received official advice from their respective

governments to defer travelling until such time that the travel risks have been assessed and stabilized.

The Executive Council Meeting in Bangkok was finalized after the National Institute of Development Administration (NIDA) agreed to host the meeting in Thailand.

PROFILE

The National Institute of Development Administration

This year's host of the EROPA Seminar on Governance as Partnership is the National Institute of Development Administration (NIDA) in Bangkok, Thailand.

NIDA was established on April 1, 1966 as a government-supported institution with university status in accordance with the Act of March 26, 1966.

NIDA began as the Institute of Public Administration in 1955 at Thammasat University. It is the only institution in Thailand and the region which concentrates exclusively on graduate studies in development administration.

NIDA offers education, research and community service through its School of Public Administration; training through its Training Center; and information systems education through its Information Systems Education Center.

The School of Public Administration offers programs both at the Master's degree level leading to an MPA (Master of Public Administration), an MPPM (Master of Public and Private Management), and at the doctoral level leading to a Ph. D. in Development Administration.

The School represents Thailand in both EROPA and the International Institute of Administrative Sciences (IIAS).

NIDA's training center is one of the oldest and best known training institutions in Thailand. The Center has recently initiated a Master's Degree Program in Administration Technology. It also offers some 50 training courses, categorized under four programs: development administration, management development, human resource development and management, and education and development.

For the next decade, NIDA aims to:

- satisfy its service receivers' needs and equip them with the knowledge and skills (in accordance with the curriculum objectives);
- be a regional academic leader in teaching, research, and academic services, which truly contributes to Thailand's economic and social stability;

The Information Systems Education Center promotes the utilization of computer technology to its full capacity in compliance with Thailand's National Economic and Social Development Plan. The Center has expanded its activities to include teaching, training, and academic service.
